New business:

Bid for oil tank was submitted by City of Carson for \$300. Moved by Stoller and seconded Reinhardt to accept bid. Tank must be removed from current location by May 31, 2020.

Patrick Diehl informed the Board of his work to obtain a generator for the courthouse. A second attempt to obtain information from Cedar Valley Fire has been made.

A request for bids for well and sewer work must be done for the County Shop in Elgin.

Reviewed letter from Red Rock/William Schneider about road going into resort.

Moved by Stoller and seconded by Reinhardt to accept quote from NRG to replace three computers and one monitor in accordance with annual equipment schedule.

Jerald Christensen from Raleigh Township met with Board about a curve in Raleigh Township that is being deteriorated by creek erosion, and possible remedies for the problem.

Jon Alt, Road Supervisor, met with the Board to discuss projects.

Moved by Reinhardt and seconded by Stoller to pay bills in the amount \$28,998.36. Roll call vote – Stoller – aye, Reinhardt – aye, Zenker – aye. Motion carried.
