

GRANT COUNTY UTILITY PERMIT

Hereinafter called the Applicant, is hereby granted permission to install and maintain the facilities as described herein on county right-of-way, of County Road

Facilities to be installed pursuant to this permit are _____ in accordance with plans, specifications and maps attached hereto,

For purposes of this permit "road right-of-way" shall mean the road right-of-way as it exists on the date of execution of this permit and shall also include that area within seventy-five feet of the center of the road right-of-way over which the Board of Grant County Commission has control pursuant to North Dakota Century Code Section 24-01-42.

INSTALLATION AND MAINTENANCE: Installation and maintenance of said facilities on road right-of-way shall conform to the following provisions:
Upon construction, maintenance, relocation or removal of said facilities, any right-of-way scars shall be removed and the disturbed areas restored to original condition, including the reseeded thereof where necessary. Trenches dug within the road right-of-way exclusive of the roadway and inslopes shall be backfilled and compacted to a density equal to that of the adjacent undisturbed soil. Trenches dug in the roadway and inslopes when necessary shall be backfilled using only approved materials and compacted to 90% of the maximum dry density as determined by AASHTO T-180. The moisture content of the soil at the time of compaction shall be not less than 1% below the optimum moisture content nor more than 2% above the optimum moisture content. All costs incurred with regard to inspection and compaction testing conducted by Grant County or its designees shall be borne by applicant.

TERMS AND CONDITIONS: Installation and maintenance of said facilities on the road right-of-way shall be subject to the following terms and conditions:

(A) Installation, maintenance, relocation, and removal of said facilities on the road right-of-way shall be done in a manner satisfactory to and subject to supervision by the County Road Superintendent for the Grant County Roads & Bridges Department.

(B) Grant County shall not be liable for damage to said facilities resulting from construction, reconstruction, expansion, alteration, maintenance, replacement and repair of the road. Applicant shall hold the County harmless for injury to persons or damage to property resulting from the location of said facilities on road right-of-way.

(C) Applicant shall repair or replace road structures and appurtenances, and any existing facilities located on, over or under the road right-of-way, which may be damaged as a result of the installation and maintenance of said facilities on the road right-of-way.

(D) Applicant shall promptly remove said facilities from the road right-of-way or shall relocate or adjust said facilities at its sole cost and expense when requested to do so by the County.

(E) No construction shall be permitted across any county roadway. All facilities must be bored beneath all paved and gravel surfaces at a minimum depth of 4 feet below the ditch bottom.

(F) All electric power, cable television, telephone services, gas and water lines shall be to Engineering Standard (if applicable) or a minimum of 4' deep from the lowest point in ditch, and placed in conduit with proper signage.

(G) Signs must be placed at far side of ditch; and purchased from county (2) one on each side.

WHEREAS, the terms of Section 24-01-42 of the North Dakota Century Code, provide that the Board of County Commissioners may grant such a permit, and it is approved by the Board of County Commissioners this _____ day of _____, 20_____, at _____, North Dakota.
