John Sauber met with the Board to discuss priority list of projects to submit for infrastructure funding. Reinhardt recommended bridges known as the Campbell; Redman; Gaugler; 104-01, which is north of Lake Tschida; and the bridge north of New Leipzig.

Recording fee of \$20.00 per deed is required from the purchaser. Purchaser cannot have outstanding property tax in any North Dakota county and must sign affidavit.
